### Find the Right Attorney Terms and Conditions

### About Us

Worldwide Expos with company address PO Box 83291, San Diego, CA 92138 together with any of our affiliate companies (hereafter referred to as "Find the Right Attorney", "we", "us", or "our") provides an online platform ("Platform") where users ("Customers") can browse services available from a variety of professionals ("Professionals") (collectively, the Users) and Professionals can offer their services to Customers.

The Platform is accessible at FindTheRightAttorney.com and any other websites through which Find the Right Attorney makes the Platform available (collectively, the "Site").

Please note that, Find the Right Attorney is not a party to any agreement(s) entered into between the Users on the platform. Find the Right Attorney has no control over the conduct of Users or services provided by the Professionals and disclaims all liability in this regard.

Your access and use of the Site and Platform constitutes your agreement to comply with and be legally bound by the terms and conditions of these Terms of Service ("Terms"), whether or not you become a registered user of the Platform.

These Terms govern your access to and use of the Site and Platform and all Collective Content (defined below), and constitute a binding legal agreement between you and UBookk.

Please read these Terms and our Privacy Policy carefully, which are incorporated by reference into these Terms.

If you are not acting on a personal account and you accept or agree to these Terms on behalf of a company or other legal entity, you represent and warrant that you have the authority to bind that company or other legal entity to these Terms and, in such event, "you" and "your" will refer and apply to that company or other legal entity.

### **Definitions:**

**Tax or Taxes** mean all direct and indirect taxes. ## Account Registration

You agree to provide accurate, current and complete information during the registration process and to update such information to keep it accurate, current and complete. Any booking will specify the total fees. You agree to pay Find the Right Attorney for the total fees for

any order requested in connection with your UBookk Account if such requested bookings are confirmed by the applicable Professional.

Once Find the Right Attorneyreceives confirmation of your order from the applicable Professional, UBookk will collect the total fees in accordance with the terms and conditions of these Terms and the pricing terms set forth in the applicable Listing. Please note that Find the Right Attorney cannot control any fees that may be charged to a Customer by his or her bank related to Find the Right Attorney's collection of the total fees, and Find the Right Attorney disclaims all liability in this regard.

In connection with your order, you will be asked to provide customary billing information such as name, billing address, and credit card information either to Find the Right Attorney or its third party payment processor.

You agree to pay Find the Right Attorney for any confirmed order made in connection with your UBookk Account in accordance with these Terms by one of the methods described on the Site or Application.

You hereby authorise the collection of such amounts by charging the card provided as part of the order, either directly by Find the Right Attorney or indirectly, via a third party online payment processor or by one of the payment methods described on the Site or Application.

If you are directed to Find the Right Attorney's third party payment processor, you may be subject to terms and conditions governing use of that third party's service and that third party's personal information collection practices. Please review such terms and conditions and privacy policy before using the services.

Once your confirmed booking transaction is complete you will receive a confirmation email summarising your confirmed booking.

# **Cancellations and Refunds**

If a Professional is unable to complete the order for the services for any reason, the Professional must inform the Customer of this and cancel the order on the Platform. If you have already paid for the order, we will refund you the full amount as soon as possible.

Once you, as Customer, have submitted your order and your payment has been authorised as per above, you will not be entitled to change or cancel your order in any way, nor will you be entitled to a refund of any kind.

### User Conduct

In connection with your use of our Site and Platform, you may not and you agree that you will not:

- violate any local or other law or regulation, or any order of a court;
